

## Health & Safety Event Protocol

Elia is taking all reasonable precautions to keep you safe when you attend the Execs 2021 event. The following measures will be in place to address the risks posed by COVID-19.

1. All registrants, in order to attend the Execs 2021 event, are required to **hold a vaccination certificate issued by a legal authority no sooner than 14 days prior to the event or a certificate of recovery issued no sooner than 30 and no later than 180 days after the day of the first positive COVID-19 test**. Registrants are requested to provide Elia with a copy of their certificate of vaccination or recovery at the time of their registration or with minimum 4 days prior to the event by email: [dimitra.garantzioti@elia-association.org](mailto:dimitra.garantzioti@elia-association.org). Attendees will not be granted access without a vaccination certificate or a certificate of recovery.
2. As an additional precaution, **attendees are required to perform a PCR molecular test within 72 hours or an antigen (rapid) test within 48 hours prior to the morning of the event**. For your convenience antigen (rapid) tests can also be performed at the Elysium Resort & Spa (exact time slot to be confirmed ). The cost is €20 per person. Proof of result should be shown upon entry for both dinner and meeting rooms.
3. A compliance Covid 19 Officer will be available on site.
4. As per current Government requirements we would like to inform you that it is mandatory to wear a face mask in all indoor spaces, including the venue (except when eating or drinking), public transport means, taxis and coaches. In indoor restaurants and cafeterias only vaccinated guests are allowed.
5. Elia will not provide printed materials (nametags, brochures, etc.) for this event as per Greek regulations.
6. Rest assured that the venue has all necessary health & safety measures strictly implemented to reduce, as much as possible, potential exposure to Covid-19 for all guests. 7. Disinfectant hand sanitizers will be available during the event and all presentation equipment will be sanitized between presentations.
8. A 1.5 meters social distance policy will be applied in the meeting rooms with 50 delegates per room - subject to change should Greek regulations be modified.
9. Guests that participate in any official Focus on Executives 2021 activities (meals, tours, etc) must abide by all listed in this document.

It is recommended that all attendees avoid "risky" situations such as mass gatherings within one week prior to the event. We also recommend taking the PCR or antigen (rapid) test prior to departure towards Greece. In addition, at the event venue, we suggest avoiding interaction with other Focus on Executives attendees if either of the parties haven't received a negative PCR or antigen (rapid) test result within the previous 48 hours.

Also we would like to inform you that up to now, all travelers to Greece must fill in their PLF with minimum 24 hours before entering the country and must hold ANY of the following documents: A negative PCR molecular test result from a laboratory; A negative antigen (rapid) test result from a laboratory; A vaccination certificate issued by a certified authority; A certificate of recovery from the SARS-CoV-2 virus infection. We remind you that the Government plan for dealing with the disease is assessed and updated on the basis of the daily epidemiological data. We will keep you posted with any new information relevant to the event and your stay in Greece.
